From the NIDM

Executive Director's Desk

Dear Readers.



In April-June, NIDM conducted a course on Urban Floods: Risk Assessment, Mitigation and Management, a timely reminder that cities, while engines of growth, are increasingly prone to hazards. Another training programme on **Psychosocial Care in Disasters** reiterated the fact that disasters do not just damage buildings—they affect minds, families, and communities. A course on Early Warning Systems equipped participants with knowledge on last-mile connectivity, community-based alerts, and the integration of traditional and scientific knowledge. The course on Integrating Disaster Risk Reduction (DRR) with Gram Panchayat Development Plans (GPDP) was a powerful step toward decentralised resilience. On World Earth Day, a workshop explored the intersection of climate action and disaster risk, while a unique session on Integrating DRR into Performing Arts demonstrated that creativity can be a powerful tool for communication and behavioural change.

NIDM's strategic partnerships continued to expand the ecosystem of resilience. Two significant MoUs were signed—first, with **Tata Sustainability Group** to drive climate-resilient development through corporate collaboration; and second, with Rastriya Raksha University (RRU) to strengthen national preparedness and to integrate DRR into the security and defence framework. Additionally, a **networking event** called 'Jointness' was organised by NIDM and NDMA bringing together subject experts of both national organizations in a collaborative effort to bridge the gap between research, policy, and practice. A special Strategic Synergies Meet was also organised at NIDM with key national agencies such as NDMA, NDRF, IMD, NCS, CDRI, NIUA, and MoHUA and others to strengthen inter-agency coordination and foster integrated approaches for risk reduction.

NIDM remains committed to build a safer and more resilient India. As part of this commitment, NIDM is initiating a flagship two-week Comprehensive Course on Disaster Risk Management, which will offer a complete perspective to all attendees. NIDM is endeavouring to conduct one such course every month.

Incident Response System (IRS) 02-04 April 2025, Chhattisgarh



Key Takeaway/Recommendations

- a) Need to showcase real-world insights and difficulties which experienced practitioners have faced while applying the Incident Response System (IRS) during emergencies.
 - b) Develop more specialized training programmes of this kind.
- c) Ensure disaster management plans and IRS framework should be evaluated effectively and accessible to all stakeholders.
- d) Incorporate field visits into the curriculum besides provision of practical exposure.

Earthquake Risk Reduction 02-04 April 2025, Himachal Pradesh



- a) Need to understand earthquake risk and seismic vulnerability in the Himalayan context particularly the Kangra region in Seismic Zone V.
- b) Strengthen institutional frameworks and coordination by highlighting the vital roles of DDMA, NIDM, SDRF and local administrative bodies in disaster risk reduction.
- c) Sensitizing on the need for enforcing building codes, adopting risk-sensitive land use practices and implementing stringent zoning regulations by promoting earthquake-resilient urban planning.
- d) Enhance community awareness by emphasizing the role of public participation in building resilient communities and the active involvement of school and college students fosters a culture of disaster preparedness at the grassroots level.
- e) Equip the participants with critical life-saving skills, including basic life support, bleeding control and effective triage in emergency scenarios.

Urban Floods: Risk Assessment, Mitigation and Management 07-09 April 2025, Delhi



Key Takeaway/Recommendations

- a) Need to have effective multi-agency coordination mechanism with clear defined roles, responsibilities, and operational protocols across urban governance tiers.
- b) Integrate flood risk management combining structural measures, nature-based solutions, and policy-level interventions which is crucial for building long-term urban resilience.
- c) Operationalizing advance flood forecasts using integrated hydrological and hydrodynamic models, thereby enhancing preparedness and reduces emergency response time.
- d) Implement standardized, city-specific SOPs for pre-monsoon, monsoon, and post-monsoon phases that strengthens operational readiness and inter-departmental coordination.
- e) Lessen urban flood hazards by integrating a real-time flood forecasting and spatial decision support system with GIS-based alerts and reservoir operation procedures.
- f) Adopt green infrastructure and stormwater management modelling techniques to minimize urban runoff and enhancing infiltration.

Integration of Disaster Risk Reduction (DRR) with Gram Panchayat Development Plan (GPDP) 21-23 April 2025, Sikkim



Key Takeaway/Recommendations

a)	Develop Village Disaster Management Plans (VDMPs) and Panchayat-level Disaster Management Plans (PDMPs) through participatory processes involving local communities, Panchayati Raj Institutions (PRIs) and relevant stakeholders.
b)	Conduct HVCA to identify local hazards, assess vulnerabilities and evaluate community capacities.

- c) Organize training programmes for PRI members, local volunteers and community members on disaster preparedness, response
- and recovery in order to enhance local capacity to manage disasters effectively. d) Establish mechanisms for monitoring and evaluating the implementation of DRR measures within GPDPs to ensure their effectiveness and make necessary adjustments. e) Foster collaboration between various government departments, local bodies and community organizations to ensure a coordinated approach to DRR within GPDPs.

Psychosocial Care in Disasters 21-23 April 2025, Delhi



a)	Need to incorporate insights from diverse disaster interventions and ensure effective information dissemination.
b)	Due to existence of limited researches on the psychosocial needs of men and women, the distinct psychosocial requirements of men and women are needed.
c)	Encourage International agencies, especially UN entities like World Health Organization, United Nations International Children's Emergency Fund, United Nations High Commissioner for Refugees and United Nations Population Fund

	to participate in Psycho-Social Support and Mental Health Services in Disasters (PSSMHS) activities during disasters.
d)	Non-disorder interventions like crisis intervention, emotional first aid, grief counselling, group therapy, play therapy and community self-help groups are essential for restoring psycho-social well-being in subsequent disasters.
d)	Address the psychosocial needs of children, using reflective and interactive activities like role-plays, clay modelling, and emotional mapping.

Workshop on Climate Adaption Policy and Guidelines for Resilient Highway Bridges, 03 April 2025, Delhi



A national consultative workshop was organized by the National Institute of Disaster Management (NIDM) under the project titled 'Development of National Highways Climate Adaptation Policy and Guidelines (HighCAP)' at NIDM Rohini campus. The workshop aimed to enhance the understanding of the impacts of climate change on highway bridge infrastructure and promote the development and implementation of effective adaptation strategies.

It sought to provide participants with practical knowledge on innovative practices for building and maintaining resilient bridges. The workshop helped collate the key recommendations for updating existing codes, guidelines and suggestions by bridge experts to build the capacity of decision-makers to integrate climate risk assessments into bridge design, maintenance, and management processes.

Workshop on Disaster Preparedness, 09 April 2025, Delhi

The Disaster Preparedness Team of Miranda House, Delhi University in collaboration with the National Institute of Disaster Management (NIDM) hosted its annual academic fest SASHAKTH 2025. The fest was centered around the theme 'Role of Women in Disaster Risk Reduction'. The event aimed to engage and inspire students across the University of Delhi.

The fest featured a variety of competitions, including debate, photography, poster-making, short films and an exciting treasure hunt. The event was addressed by Ms Atisha Sood, Consultant - Health, NIDM, who shared valuable insights on women's leadership in disaster resilience. She deliberated on 'Women as Changemakers in Disaster Risk Reduction: Leadership, Challenges, and Opportunities in the Indian Context". She further focused on the initiatives like Self-Employed Women's Association (SEWA), Mahila Housing Trust (MHT), and Kudumbashree, a government-led program in Kerala, focuses on women's empowerment through Self-Help Groups (SHGs) and provides them with various opportunities for economic and social development. She emphasized the importance of gender-inclusive policies, youth participation and investing in women-led disaster response.



Workshop on Rise & Respond: Youth for an Earthquake Resilient Future 16-17 April 2025, Delhi





In a tribute to the 25th year of the Bhuj Earthquake, a national-level workshop was organized by National Institute of Disaster Management (NIDM) in collaboration with Sri Guru Gobind Singh College of Commerce (SGGSCC), University of Delhi, under the National Capacity Building Programme on Earthquake Risk Reduction.

The workshop was inaugurated by Dr. Jatinder Bir Singh. Principal, SGGSCC, the event featured expert sessions by Dr. Amir Ali Khan (Head, RID, NIDM), Dr. Preeti Soni (IUINDRR-NIDM) and Dr. Pankaj Kumar (Assistant Professor, NIDM). Participants gained practical knowledge on preparedness, mitigation strategies and the role of youth in disaster management. The workshop inspired innovative thinking through competitions that received over

450 entries, highlighting creative solutions for resilience building. It fostered youth leadership, encouraged community outreach initiatives and strengthened academic collaboration for disaster risk reduction. Participants expressed commitment to apply the knowledge gained through awareness campaigns, mock drills, and advocacy for integrating disaster education into academic curricula.

Competitions were judged by Dr. Garima Aggarwal (Senior Consultant, NIDM), Ms. Nazia Khan (IPRO, NIDM), Dr. Neelu Anand Jha, Dr. Babita Singh, Dr. Ravish Lal, and Dr. Pratibha Kumari. The workshop concluded with a prize distribution ceremony and closing remarks by Dr. Neha Goyal who was the convener of the programme.

In later sessions, emergency response leaders from NDRF, Fire Services, and Civil Defence shared ways to boost speed and coordination when every second counts. The final discussions championed the use of satellite technology, robust seismic codes, and smarter planning for a futureready India.

Concluding with valedictory remarks by Dr. O.P. Mishra, Director, NCS (National Centre for Seismology) and a clear way forward from Shri Rizvi, the workshop reaffirmed one truth: governance and resilience must go hand in hand. When they do, policy transforms into people in action and that is how a safer tomorrow is built, step by step.

The way forward calls for continued dialogue, joint research, shared tools and databases, and cross-institutional drills and simulations.
