**Expression of Interest for Hiring Consulting Services for  
Damage, Loss and Need Assessment Study for India**

1. This request for expressions of Interest follows the general procurement notice (GPN) published in the United Nations Development Business website <http://www.devbusiness.com> on 3rd December, 2009 and Times of India on December 9, 2009.
2. The Government of India has received a credit from the International Development Association (IDA) and intends to apply part of the proceeds of this credit to payments for goods, works, related services and consulting services under this project.
3. The Objectives of the Study are:-
  - An in Depth review of the existing procedures and evaluation of existing international practices.
  - Development of uniform standards for damage and loss assessments relevant to the Indian context.
  - Development of a User handbook for conducting PDNAs based on the evolved methodology.
  - Module to train panel of experts in application of new procedure and capacity building of relevant stakeholders through ToT trainings.
4. The Executive Director, National Institute of Disaster management (NIDM) now invites eligible consultants to indicate their interest in providing the Services. Interested consultants must provide information indicating that they are qualified to perform the Services
  - a) Name, Address, Facsimile Number, e-mail ID and website address
  - b) Number of states in the country in which the firm has branches/offices, giving full addresses of the branches/offices.
  - c) Year-wise annual turnover of the firm for the last five years (along with documentary evidence).
  - d) Organization Structure of the firm.
  - e) Organizational relevant experience in Disaster Management including in conducting PDNAs.
  - f) Details of relevant Damage, Loss and Need Assessment Studies/Disaster Management by the firm in the last 5 years.
  - g) Details of relevant experience of the firm with large scale Public Organizations (govt.) and externally funded projects (e.g. World Bank, ADB etc.)Two or more consultants may associate to enhance their qualifications. [The "Association" may take the form of a joint venture (with joint and several liability) or of a sub-consultancy].
5. A consultant will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by Bank Borrowers 7 May, 2004 (revised October, 2006 and May 2010).
